A lot of great mates around you also realizing the year were of importance to get a job that you would be happy with and also having other mentors guiding you along the way!

My respect for both My Father and Mother and associated family members would be prioritized with respect.

On the 16th of December 1979, at around 4pm in the afternoon, was forming what would turn out to be a "Collusion of the Highest of Dark Forces against Me." {Meaning};- feeling that powerful, malevolent, or unseen entities are conspiring and working together specifically to sabotage, oppress, and harm Me. What it would turn out to be was an overwhelming life circumstances/Spiritual Warfare that felt orchestrated and entirely out of My control!

So as I said earlier, I proceeded to My car at about 4pm with My Mate Peter McClennan to drive home after having an enjoyable weekend at the Nobby's Beach Surf Club. 2 other Mates Steven Hyde and Brett Evens went to Steven's Car to drive home also. Steven tried to start his car but it had a flat battery. We ended up swapping batteries with push starting My car with his dead battery in it. He had an automatic transmission where this routine cannot happen.

Both cars were functional, and We were ready to proceed back to Steven's place to get My battery back for work on the Monday being the following day.

Another Mate, Mark Skelton called out to Me wanting his help. He explained to Me how he wanted to stay an extra night with his girlfriend. He wanted Me to give his girlfriend's brother Peter Privitora 15years of age and his mate

Gary Bridge 16 years of age to get them home safely, as it was their first weekend away from their parents place. I agreed to these terms and We all proceeded on our way home. Peter and Gary supposedly lived in the next suburb being Carina, to where I was residing with My Parents and the other members of My family in Cannon Hill. We never had mobile phone technology for communication or whereabouts! We turned off the Old Pacific Highway at Beenleigh and were travelling along Chambers Flat Road towards Marsden. Steven must have just avoided an out of control car coming at him, there I had no chance!

I can't remember impact but later found out that Gary died on impact and Peter who was trapped in behind Me, but lasted 1 day in a coma at the Princess Alexandra Hospital before his

I had stopped breathing, a nurse that had been travelling along the road at this timeframe analysed what she could do, and just did it! She cut My throat with a knife and put a straw in there for Me to breathe. It was later revealed that I had sustained 5 broken ribs with 2 collapsed lungs hampering My existence besides a fractured skull, depressed right cheekbone that had to be operated on to position it properly, a broken jaw in 5 places where they broke it twice more and wired it up with taking teeth out for my jaw to close properly together. I had a broken back, a broken pelvis in 2 places, with a broken left leg in 3 places with a broken left ankle, a broken right ankle with a large pin inserted to put it in

place and a broken right arm in 2 places.

I had died many times but was able to be resuscitated giving Me ongoing 'Life'!

I was unconscious for 9 days with waking up on Christmas Day 1979. My Brother had just got back to Brisbane, Australia that Day from a skiing holiday in Austria.

Peter McClennan witnessed everything, but also sustained knee injury which hampered his Australian rules future career.

So I guess it was supposed to be a time for the authorities Police/Criminal investigations to do their job.

1. Steven just avoided the car coming at him.
2. The male driver from that car got out of his car and ran down the road 100 meters to get away from

the scene of the accident and then faked unconsciousness or {factitious disorder imposed on self}.

3. He was taken to the Princess Alexandra Hospital in an Ambulance, but fled the scene not wanting to be caught out.
 4. The Police found him 3 days later. He never had a licence and had lost it 3 times before for drunk driving.
 5. He was never charged and got off at the inquest with not enough evidence against him!

Peter and Gary were left in My care to get them home safely, but as you see with All these dark forces against Me, I will use every breath in 'My Being to bring about earthly

I spent the next 8 and a half months to recover and be able to be given the 'all clear documentation' after spending 2 weeks in rehabilitation to get back to daily duties as to get out of bed, then make it with clean sheets, being able to get about to get your own meals and coffee etc, and toileting, then showering then getting yourself clothed and ready for what was to come.

Peter McClennan and another mate wanted to take Me for a belated Birthday drink and officially being 18 years of age at the Mansfield Hotel. It was mid-to later August, after My real Birthday being the 16th of July. I got picked up from My Parents house about 6.30pm. We arrived at the Pub then I had 2 pots of beer then I would be returned to My Parents house. We

walked out of the Pub and a bloke started yelling, have you got my glass or glasses? We kept walking towards the car parked in the car park about 30 meters away. There must have been about 9 blokes wanting trouble on My official night of being legal to have alcohol. 1 bloke came running at Me! What could I do? I was going towards a garden bed to get out of the way! I looked towards this bloke who was running towards Me, and got king hit from behind! I looked up to see what was happening then got kicked in the face, with My Nose being planted against My right cheekbone that had been depressed at the car accident! Blood was all over My body! My 2 mates were able to protect themselves to a certain degree. The bouncers came to see what they could do! They rang My Brother Wally

and before I knew what was going on the bloke who kicked Me in the head was 'apprehended'.

My nose and My left arm were the only major parts to My Body that had not been broken in the car accident!

Before having My nose repositioned and 5 stitches inserted into the gaping hole from his shoe laces, I would have to go and identify out of a group of people gathered by the Police for identification! I identified the bloke as My blood was all over his steal cap boot with a chunk of My nose also on it!

He was charged with assault and given a date for prosecution!

My Brother Wally personally picked Me up from Mum and Dad's residence and laid Me across the back seat of His 260z sports car. We went inside the Chambers of the Holland Park Court House for a private legal conference.


The bloke never showed up! So once again Our great Court system failed Me again! How could this bloke avoid not being brought to justice of an earthly judgment 46 years later!

As you are a Witness, things get much worse for Me over this 46 years with uncovering some of the worst acts of violence and conspiracy out there!

Brisbane, Queensland, Australia was a hot spot for illegal activities that progressed through many years!

The Whiskey Au Go Go was firebombed. 2 drums of fuel were thrown into the downstairs foyer and ignited at approximately 2:10am on March 8 1973 trapping patrons and staff. 15 people died from carbon monoxide poisoning before fire fighters arrived on the scene.

The Attack and Convictions; prior to the bombing, a wave of extortion

attempts and arsons plagued Brisbane's nightlife, with several clubs receiving threats from Sydney-linked criminals. At the time it was the worst mass killing in Australian history.

My next major incursion that was dealt on Me by the authorities of this world was leading up and to My 26th Birthday in 1988. This was supposedly the Celebration of Expo 88 that had been taking place at Southbank, South Brisbane.

My Father was the Coach of My younger Brother Heath's under 18 team that would go onto win the Premiership. On the 15th of July they had a fund raiser on that evening and then We proceeded to Southbank on the way back home. I let some of the players also including My Brother Heath know I was going to inform My Brother Wally know that I had already picked up My Birthday

present being from the family as it was a leather jacket. I went to the top section of the Ship Inn Hotel to gain entry where the bouncer informed Me Wally was in the downstairs bar area and I would have to gain entry at the side entrance. I spoke with the bouncer and he allowed Me to gain access. Everything went wrong when 1 of the player's from My Brother Heath's side tried followed Me in. He was dragged out! I went out to try and settle things down. All of sudden I had 1 arm being forcibly restrained above My head, then the other 2 blokes who were wearing these 2/3rd lengthen jackets were continually punching Me to the head and 1 bloke bringing his knee into My ribs area. My Brother Heath saw what was going on and dived/launched Himself to bring everyone down.

4 of Us were taken away Police cars. These 2 blokes that got me initially took Me to their car. These 2 were undercover Cops. So as we were driving in front of the Croquet club near Musgrave Park, I spoke out saying I would have loved to be Wally's size meaning My Brother for protection! The copper who was driving the car and was well over ~~6~~ foot tall, screeched his brake on and the car came to a halt. He unbuckled himself and positioned himself in the passenger front seat. He continually punched Me to the head with the other copper kneeling on the passenger backseat and bringing his knee up to My head! This went on for minutes! The undercover copper then got himself back in the driver's seat! When driving off he said to Me, "make sure you give that to Wally, won't You?"

The 4 of Us were charged with assaulting police without any of Us throwing 1 punch.

Both Myself and My Brother Heath were written up in the Newspapers for assaulting police.

Wally made sure He took Me with Him to a Brisbane Broncos function that day being My 26th Birthday, but also showing Wayne Bennet how corrupt the police force were with Bennett being up the ranks. Wayne Bennett always had a beef with the Lewis Family where My Father James Lewis beat him with Wally in the under 18 Grand Final against the Queensland Police side with the likes of Mal Maninga.

At Our Hearing Terry O'Gorman was to take up Our 'Fight for Innocence', but He never showed up leaving his

Terence Murray {Terry} Lewis was a former Queensland Police Commissioner who became 1 of Australia's most infamous figures after being exposed by the Fitzgerald Inquiry. He served as Commissioner
