I went to the Mater Public Hospital on the 20th of April 2026. I had extensive xrays to allow for examination by Doctors. I went in to the room wondering and wanting to know why I was in so much pain with my knee and hip. The first doctor was concerned at what he saw so he went to superior Doctor. It was the same Doctor who was going to give me a knee replacement back in late May 2025. Mathew from workcover rang me up say I needed a second opinion so I had to turn down the knee operation regrettably. I was informed I had to go to my GP and get a knee surgeon myself. I got a list of 10 names of Knee Surgeons to engage 1 out of. Dr Meta who ran out of Greenslopes Hospital. After many months allowing my knee to settle down he operated taking out 2 massive meniscus tears. Nothing changed with the pain after the operation. The last time I saw Dr Meta was Monday the 9th of February 2026. I told him at this appointment how I was in so much pain. He gave me a referral to have a needle with stuff in it to stop the pain. The needle did not stop the pain. Dr Meta closed my case. Before that last meeting with Dr Meta I demanded another MRI. This was done in early January. When I met Dr Richardson on the 29th of January 2026, he showed me the 4 MRI results. He showed me the damage I did to the knee with the first 1. Then showed me the next 2 but after the 4th MRI he showed me after the operation in September the following year my tibia and fibia were bone on bone rubbing. When leaving he told me I needed a new knee. We shook hands and I left. I rang my brother Wally up that night extremely happy. In a February I was given an email to say I would be given a 16000 dollar payout and had 28 days to accept or not. I did not accept as I have engaged my own solicitor. I was still employed at the time. I took 3 weeks of sick leave then resigned through injury. It is now 3 weeks since this time and I am living off accessing my superannuation. So getting back to April the 20th my 2 Knee Doctor at the Mater Hospital my Doctor is to reopen workcover and is going to operate personally within a the month time frame but has put me at the top of the list. In prayer through the night and I am personally sue Workcover for 20million dollars in compensation for related injury and pain incurred with corruption within workcover. This will be done through a Legal Documented Affidavit, yours faithfully Edwin Lewis this will also be used within my Testimony www.jesusisthehighwaytoheaven. I CONVICT THE WORLD IN JESUS' NAME.

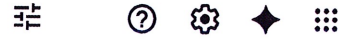
