



My 2 biggest 'Witnesses' in my life at this present time in history are My Mother June and My older Brother Walter {Wally}. I lost my best mate being my Father James {Jim} who preceded Heaven bound at 9.45pm on the 15th of August 2024.

There has been 1 chapter of My Testimony, where I have not been able to close it. I had a work injury on the 3rd of March 2025, I did let my boss from Acciona, Danny know straight away. I was climbing up into a truck that was missing the step-up which had broken away. It was a confined space where I wasn't able to open the door more than 2/3rds of the way. When I reached up to the handle to swing on and then to get

my legs either side of the peddles as I grabbed for the steering wheel, my steel cap work boots hit the rubber mat flooring in which they clung to it and both my knees kept going and a loud snap happened to my left knee. It burned straight away. I then worked for another 2 weeks putting up with the intensive pain level.

Besides being contracted to Acciona from Civforce Traffic Management from Monday – Friday, A cyclone had hit the Brisbane/Gold Coast areas and I was doing extra contracted work for Energex Electricity. These were 12 hour shifts on the Saturday and Sunday.

On Friday the 14th of March 2025 at pre-start, I thanked everybody at work, over the past 18 months for accepting Me as a college worker but I needed to get my knee checked out at the Princess

Alexandra Hospital on Monday the 17th of March 2025 and that I would be moving on to a different site. Danny was a great Boss, but some of his workers were terrible people the way they were treating me. I was carrying out many more tasks than I should have been doing, but just tried to keep everything moving. There were 2 shifts day/night. Night shift were shocking and not working with Danny being day shift Supervisor. It would always take up extra time every day to fix up the mistakes from the night before. Danny also had time lines he had to stick to. It was a huge operation at South Brisbane putting in Bus ways and shelters. On 1 occasion, nightshift did not release the water from the water barriers where Danny was to have a pedestrian walkway changed to progress his works from one area to

another. He told me this needed to be done. When the workers released the water from the barriers, water was flowing freely with some pedestrians getting wet feet. A while later obviously after a couple of complaints from the public, Brian the Boss of Acciona confronted Danny yelling at him. I was close by and witnessed Danny being assaulted with 5 pokes to his chest and Brian saying, "You're a disease and your infecting your workers." Myself and Danny had a chat later about it and we both said he was lucky not to be sat on his arse!

I would have to look after the Site for deliveries, make sure everyone was inducted, make sure no one was parking in the wrong areas, escorting vehicles, trucks and also concrete trucks and shielding them as they were getting to

the proper location by also using my 2 way radio/walkie-talkie. Many people would get lost, so I would try and guide them where to proceed to, but also some did not know much English language. Some days I would have 5 sets of keys in my pocket to make things work-out! When I was out doing various jobs away from the Site, I was to lock the main gate, with workers only accessing through a small gate.

On Sunday the 16th of March 2025, being the last day of work, I was closing off a lane and doing stop/slow in front of the Surf Club at Surfers Paradise. In the last 2 weeks of work, I made 1750 dollars and the last week 2,350 dollars on a 28 dollar an hour wage. I have all the proof. I presented myself at the Princess Hospital at 2.45am on the 17th of March 2025, as my leg was in shut-down mode.

I let Civforce Management know what was happening and told them they needed to pick-up the work vehicle/traffic control manual ute, as I knew I would be off work for an extended period of time!

From this date till now my leg still seems the same. I had an MRI on the 18th of March 2025 showing I had a fractured tibia, 2 big meniscus tares and tore the 4 muscles inside the knee called the quadriceps.

I went from going to the Princess Alexandra Hospital, where they were terrible to the Mater Hospital hoping for better treatment. Through the Mater Hospital and Knee Surgeon Doctor John Paul McNicholl, He was going to put my name down for Surgery back at the end of May/June 2025.

For 7 weeks Work Cover were not going to support me in my case. Then I mentioned I was going to engage a Solicitor on this particular Friday on the phone and in an email sent to them. On the Monday they rang me back to approve it. I had gone through 3 weeks of my sick leave, and 4 weeks of my holidays by this timeframe.

I had just left the Mater Hospital where I had just left Dr John McNicoll arranged appointment.

Mathew from Work Cover rang me up to say I would have to get a second opinion. I had no money coming from work and I reluctantly agreed. Work Cover paid me for the 7 weeks at a bit over a thousand dollars a week and Civforce would have to reinstate my 3 weeks of sick leave and 4 weeks of annual leave with me having

to pay back Civforce the money they gave me for the 7 weeks.


I had to go to My G.P Doctor and get a list of ten names of Surgeons' to give me a second opinion. I had no idea what I was doing but made the first call to a Surgeon Doctor Meta that ran out of the Greenslopes Private Hospital. My leg was not settling, He operated on my left knee on the 16th of September and cut out 2 massive tares of the meniscus muscle. I attended his clinic over the next few months where my leg was still really sore and making me so tired. Later in December I was pleading to get another MRI to see what was going on. On the 8th of January I went for my 4th MRI.

On the 29th of January 2026, I attended a Clinic at the Wesley Hospital at Auchenflower, for a specialized knee surgeon from Work Cover's side to

evaluate my knee. I explained to him how it happened and the problems I have been having with the pain and mobility problems. He said to me, or words of the same meaning, "Here are your 4 MRI's, the first 1 shows your work injury, 2 and 3 not much difference, but with the 4th after the operation, your tibia and fibula are rubbing together, bone on bone. When leaving, he said you will get a new knee, we shook hands and I left. I rang Wally that night to let him know! I attended my last time with Dr Meta on the 9th of February 2026. I was in so much pain and he gave me a referral to get a needle in my knee to stop the pain. I did this the following day. 1 of Doctor Meta's Receptionist's was telling me it was the arthritis in my knee why my File was being closed.

Mathew from Work Cover told me that they were closing my case after Doctor Richardson gave me a 4 percent disability relating to my knee injury. He said nothing about me getting a knee replacement. I wasn't happy! I rung his receptionist up whilst I was 'Irate' and told her to tell him I was not happy. I also sent an email stating the facts of our consultation with concerns of being bias against me.

~~Nathan~~ had given me 28 days to accept Work Covers measly payout figure, compared to my own Solicitor's evaluation.

The 3rd of March 2026 was the last day for me to accept the deal. Since then I took 3 weeks of sick leave owed to me through Civforce Traffic and they have paid me my remaining holiday/

Severance payout as I am unfit for work with my knee being the way it is!

I went to center link on 2 occasions, with little help.

I have had to draw out my nearly 32,000 dollars in Super to help me as I am going through this court process. It has been about 5 weeks in seeing my money being eaten away!

So everything changed from where I went back to my GP and she sent off papers to the Mater Hospital to get matters happening again.

On the 20th of April, I attended the Mater Hospital for extensive x.ray results. I then went to be seen at the knee Orthopedics Room for evaluation. I went in and met a Doctor. Straight away he saw things that were not right! He said that he would consult with the specialist in charge. He returned with Doctor John Paul

McNicholl. He was the Doctor from last year who was going to give me a knee replacement. He looked at everything put in front of him with the 4 MRI's and the latest x-rays.

He said straight out to me, "WHAT HAVE THEY DONE TO YOU." He said how he was going to re-open the case with Work Cover and told me I will be getting a new knee! I would be a category 2, but I will be first on the list for a new knee. I proceeded to pre-operation process which included blood tests.

WOW FINALLY!

I 'Prayed' about things that night!

I sent Work Cover an explicit document letting them know I am drawing up papers to sue them for 20 Million dollars for what they have done to me and the pain incurred.
